## AND NOW a WORD from our PRESIDENT :

As the holidays dwindle, I want to take a few moments to thank your Board of Directors, fellow Officers and members of the nascent Play Lot committee for their selfless devotion to the cause of improving our corner of the city. Planning the monthly meetings is no mean feat, and the quality of the programs we have had this past year is testament to the board members' pitch-in attitude. Because many of our members have deeper roots and broader contacts in the area than I, I have depended on their arranging not only the mechanics of our meetings, but also the speakers and the refreshments. Our holiday party last month is a perfect example. Together, they procured the food, made the liquor baskets and secured the gift certificates for our raffles, then set up the tables.
