Dear Neighbors,

By the time you read this, I will have paid my 2nd half 2010 property taxes. Now that I have retired, and with the exception of my son's graduate school tuition (hopefully ending soon), my two property tax payments are the largest checks I write every year. With a 14% increase over last year's tax bill (what happened to Emanuel's no-new-taxes pledge?), I

wonder what I get for the money. The stated wisdom is that 52% of my property tax bill goes toward public education, but as I read my bill, it's closer to 58%, counting the Chicago City Colleges and something called the Chicago School Building and Improvement Fund (do they think that they can educate children without buildings?). In the 20+ years that I have been a property-tax payer for three dwelling units, there has been exactly one year's demand for a public school education-that which eats up majority of our tax dollars. For those who send their kids to private or parochial schools, the return is even worse. What gives?

This may not be the time or place to debate property tax reform, but with the top three officers of the State of Illinois (our dear Governor, the president of the State Senate and the Speaker of the General Assembly) having made (and continuing to make) their bones in the Cook County property tax game, there is a vested interest in keeping the system as broken as it is. Reassessments, equalizers, exemptions, all



require lawyers and accountants to finagle (did I say that all three of these officers are lawyers, the two in the legislature with active practices?), and if there's anything that breeds lawyers it is other lawyers in the legislature passing laws that make the simple complex. Sadly, there's no Herman Cain touting a simplified 9-9-9 property tax system (no more than 9% of annual rental value-or rents if the property is leased to others; no more than a 9% increase in any year-including reassessments; no more than 9% of income from all sources-to provide for seniors or others on a fixed income) to replace the Rube Goldberg gimmicks we have now.

While the schools devour the majority of our tax dollars, the jobs of assessment, apportionment and collection lie at the county level. Our Cook County Commissioner, John Fritchey, will be at our November meeting; perhaps he will address some of these issues. Fritchey is our former state representative and evidently after tiring of the Springfield commute (can you blame him?), he ran for the commissioner's vacancy created when our Congressman Mike Quigley won Rahm Emanuel's seat in an early 2009 special election. Perhaps other members would like to ask Fritchey what he is doing to overhaul the "corruption tax" that Cook County residents pay so that the Todd Strogers of the world can employ their relatives in lucrative positions and give cronies no-bid contracts. I would do so, except that may open me up to charges of being "too political".

Clark Kerr, the former chancellor of the University of California, said that running the university had been reduced to worrying about "sex for the students, football for the alumni, and parking for the faculty". I share his concern that parking problems magnify beyond all bounds: since the Belmont Medical Building of last year, no issue has generated more heat than the single ZipCar parking space at Lakewood and Wellington. Even in the genteel quarters of a board meeting held in St. Al's rectory, tempers flared. While it appears that this one space has been set aside pursuant to city ordinance, members will have the chance to vote to ask the Alderman to rescind the ordinance, and separately on whether other spaces in our neighborhood should be set aside for "car-sharing" programs like ZipCar.

One other presentation for November will be from Burley School where a group is planning a re-do of the rear playground. I use the term playground advisedly: it is simply an asphalt pavement with faint lines on one end demarking only a basketball court (without nets, of course). Having grown up on asphalt playgrounds and bearing the scars of doing so, I hope that the future generations of Burley students will enjoy a playground that is not a hazard.

This is my last communication with the members before Thanksgiving. With our economy still on its back three years into a recession, some may think that there is little to be thankful for. But I am grateful that South Lakeview neighbors still exists to support the community and that the community exists to support its members.





Mr. Quigley will give us a full-blown report from Washington D.C. on the war, political gridlock, budget deficits, job creation and unemployment among other topics.

COOK COUNTY COMMISSIONER – JOHN FRITCHEY

Frequent visitor to SLN meetings, Mr. Fritchey will unveil his call for a New Marijuana Policy of ticketing for possession making practical and economic sense among other Cook County issues. As many of the SLN members were teenagers during the late 60's and early 70's, this should be a topic of interest.

BURLEY ELEMENTARY SCHOOL – Friends of Burley – www.freindsofburley.org

Friends of Burley (Burley School) is a non-profit 501(c)3 organization focused on raising funds for various projects for the Burley School. The Friends will present plans to convert the old paved play space at Burley to a new community park and playground including an artificial turf athletic and play field, a soft running track, new basketball court, landscaping and more.

ZIP CAR STREET PARKING – Lakewood & Wellington

There will be a discussion and a vote on the issue of private businesses being allocated public parking spaces to conduct for-profit business. This issue has arisen as a result of a parking spot on Lakewood being allocated to the ZipCar venture without neighborhood input. The SLN Board has been communicating with the Alderman's office on this issue. The immediate area will be flyered and there will be a VOTE.

AT THE OCTOBER 2011 MEETING

STATE REP. ANN WILLIAMS

This was Ms. Williams' first visit before the SLN brethren since her election. She encourages residents to sign up for her newsletter and email her with issues that are important.

She admitted that she is still in the breaking in process of Springfield politics. Though the State is

in dire financial straits, she tried to accentuate the positives that are happening in the State.

Ms. Williams has been involved in working on various legislation including 1) workers compensation legislation that will make Illinois a more competitive work environment, 2) education reform to lengthen the school day and set teacher standards, 3) keeping smoking bans in all public places despite lobbying from the casino industry, 4) medical marijuana issues, 5) reproductive rights opposing limitations to restrict abortion, 6) concealed gun laws opposition.

Ms. Williams personally worked on issues involving 1) new cancer treatments that are not being covered by health insurance companies, 2) environmental issues with legislation for small systems energy including solar, windmill and turbines and 3) the smart grid bill for ComEd upgrading of the current electrical system, vetoed by Governor Quinn but recently overridden by the legislature.

Budget – the “good news” was that the current budget was passed with a bi-partisan effort as opposed to the normal back-room dealing. Different than in previous budgets, each program had to be fit into the predetermined budget number, not the opposite as in prior years. The “bad news” is that pension payments have been skipped, revenues are down as we are in a recession and there are millions upon millions in bills owed to vendors that have provided services to the State. The projection for revenues is not growing. The current system of sales taxes based on the sale of goods is antiquated as the economy is predominately a service industry. Most states have taxes on services. The flat state income tax may be changed to a progressive rate like the federal tax. None of this can be good for us in the future.

Ms. Williams opened the floor for questions. She touched on increasing real estate taxes and the methods the State is attempting to keep them down and find alternative sources of revenue. She noted that with all the bad press Illinois has been getting, Blagovich, tax increases, etc., it has been hard to attract business to Illinois. She noted the State is working on business development and planning. Funding for libraries, like all services is being cut. Hours and services will be reduced. She


