IN THE NEIGHBORHOOD

Here are some law reminders from Alderman Waguespack's website:

Snow Removal - Many people rely on walking and transit as their primary way to get around, and without a wide, clear path through snow and ice, it is especially difficult for people with disabilities, seniors, and children to walk safely. According to the Municipal code of Chicago (4-4-310 & 10-8-180), property owners are responsible for keeping sidewalks clear of snow and ice. If you have an elderly or disabled neighbor, please consider helping them shovel. You can also contact the alderman's office and they can see if a volunteer is available to assist in this situation.

Leash Law - According to Municipal Code 7-12-030, anytime you take your dog onto public property (excluding a city dog park), it needs to be leashed. Any owner who violates this law can be fined \$300 per violation and up to \$10,000 plus jail time if an attack occurs while your dog is off leash.

Many times, people are confident that they will be able to control their dog without a leash; however, you are risking your pet's and others' safety whenever you have your dog unleashed. It's possible something might startle your dog, which could cause it to run into traffic. It's also possible another animal might try to attack, and without a

leash, it will be harder for you to be in control of the situation. For everyone's safety, including your own pet, always err on the side of caution and keep your dog leashed.

Picking up where the Lakeview Area Master Plan left off in 2011, the Lakeview Chamber of Commerce began a Lincoln Avenue beautification planning process in fall 2013 with the goal of making the stretch of street between Diversey and Belmont a more attractive place to visit, live and do business. 






Lakeview Book is Out
