Hi South Lakeview,

I, for one, am happy that 2020 is over, and I am looking forward to a better year in 2021. We have a new President, Joe Biden, and a new Congress that may bring more aid to struggling states and cities that have lost significant tax revenues. Hopefully, some direct assistance to small businesses and individuals will be coming, as well.

It appears that COVID vaccines are becoming more available. We will hear updates from the Chicago Department of Health at our Feb. 9 Zoom meeting. If you are over 65, call your local health care provider or contact your local pharmacy to try to schedule an appointment for the vaccine. Currently, the two vaccines from Moderna and Pfizer require two doses. Remember, that even if you get inoculated, mask wearing, social distancing, and hand-washing must continue. Chicago's adherence to these guidelines has led to a lowering of our positivity rate. If we all follow these guidelines regularly, we can lower the spread of the virus and approach a degree of normality.

### Business Updates – within the SLN boundaries

#### Herdegan Funeral Home development update

The SLN Board had a ZOOM meeting with the current Developer and Attorney for the never ending Herdegan Funeral Home project. The Developer, Jack Duncan of CA Ventures was involved with project as an investor and has taken over the Development after others involved were not getting the job done. Mr. Duncan projects an April 2021 completion and occupancy of the Development. His own business, CA Ventures, intends to occupy the 1<sup>st</sup> floor commercial space. The 2<sup>nd</sup> floor will be leased to various medical offices. The residential part of the Development, floors 3-4 will be three or four bedroom high-end rental units commanding rents from \$4,000 to \$7,000 per month for the four bedroom unit. The Developer plans to market the units for family-oriented tenants selling the top-notch neighborhood schools in the area. This Project has been going on since May, 2015 and we will all be glad the when the building becomes operational.

#### Restaurants

Some restaurants have closed, but the entrepreneurial spirit lives on and some restaurants on 2800-2900 Lincoln Ave. have opened or are opening soon.

Gotham Bagels / Eduardo Enoteca – 2801 N. Lincoln (formerly Gino's East). The same owners (Bravo Restaurants) have closed Gino's East pizzeria and opened a hybrid restaurant selling New York-style bagels during the morning and afternoon and Italian food at night. Gotham Bagels originated in Madison, WI. and thought that they made the perfect New York bagel along with bagel sandwiches (from 8AM-2PM). The owners already operate an Eduardo Enoteca restaurant at 1212 N. Dearborn and are bringing that menu of handmade pasta, seasonally rotating items and charcuterie to Lakeview (from 2PM to 9PM). Already open. 773-530-5454.

Tatas and Tacos - 2826 N. Lincoln – specializing in tacos and burritos. The menu touts a good number of vegetarian and vegan options. They had a big heater/flame in front and appear to be open. The

Rica Arepa Venezuelan Restaurant – 2913 N. Lincoln – arepas are stuffed cornmeal cakes that are crispy outside and fluffy inside. They also have a big deck in the back for outdoor dining. ### Development Updates – within the SLN boundaries

2933-37 N. Southport and 2956 N. Lincoln – across from The Athenaeum Theatre. Three buildings on Southport and one building on Lincoln making up a pretty dilapidated set of buildings are now demolished. To be built - a 4-story, 52ft high building with 12 condo units on floors 2-4 and commercial space on the ground level. This was a SLN voting issue development. When this project is

completed and The Chase Bank rehab is complete, this will be a pretty sharp looking triangle of development.

3056 N. Lincoln Ave. – former site of many failed restaurants including Entente, which was a Michelin-rated restaurant. Now demolished. Being built – 4-story, 3 units with 1<sup>st</sup> floor retail.

3113 N. Lincoln and 3116-18 N. Greenview buildings which was a cruddy one level retail store on Lincoln and a 2-story building on Greenview that who knows what was in there is now demolished. To be built - a 4-story, 9 unit “TOD” rental development.

2800 block of Southport, next to Que Rico Restaurant is now demolished. To be built – 3 level residential condo unit building.

There a few new houses being built around the neighborhood on 1700 Barry, 1400 Oakdale and 1500 George. Though it seems that the scenario is usually a smaller frame single family house is demolished and rebuilt as a \$1.7 million plus house. However, the single-family house next to The Farm Bar on 1300 Wellington is being gutted and rehabbed, not demolished.

## Lakeview Computer Specialists

Hello again, this is Ed Silverstein, owner of Lakeview Computer Specialists here in Lakeview. This month I'm writing about your home WiFi. Whether you are working from home, the kids are doing remote schooling, or if you just use your phone: we're all using WiFi at home.

Many of you are likely experiencing slow internet speeds to do all of these often simultaneous connections. While the problem might be your WiFi, it is good to rule out the other possibilities first. One bottleneck can be the speed from your internet service provider (ISP). Cable TV providers, like Comcast and RCN offer the fastest internet here in Chicago. AT&T has a variety of speeds, but can be as slow as 10Mbps (Megabit per second). You can look at your most recent bill from your ISP, and it will show your internet speed. You probably need at least 50 Mbps for each device you might be using at the same time. With a family of 4, you would likely need 200Mbps as a minimum. You can test your speed by connecting to [www.speedtest.net](http://www.speedtest.net).

If your ISP speed is fast enough, then it is time to look at the placement of your wireless router. The closer your devices are to the router, the better connection they will have. You should also consider walls and ceilings, as they impede WiFi signals. The best solution for the location of your router is in the center of where everyone's devices are being used. Placing the router on the middle floor of your house will provide the best coverage for floors above and below.

The next category to consider is how the devices are connected to your WiFi router. A wired connection is always going to be faster than wireless. Any desktops or laptops that aren't moved around much are candidates to be wired to your router. A wired (Ethernet) cable can run along the baseboard of your wall and reach a computer quite far away.

If none of these suggestions solves your slow connection speed, then you should examine the speed of your WiFi. WiFi runs on several frequencies. Using 5 GHz is faster than 2.4 GHz. The downside is that 2.4 GHz provides better range than 5 GHz. If your router is less than 5 years old, it probably supports "dual band", which means it speaks both 2.4 GHz and 5 GHz. If your devices are close enough to the router, then the 5 GHz band will be a lot faster than connecting at 2.4 GHz.

There are other, more technical, solutions, such as new routers that support WIFI 5 and WIFI 6 protocols, but I'm not going to get into those details here.
