### APRIL 2021 "ZOOM" MEMBERSHIP MEETING – PREVIEW

#### **State Senator Sara Feigenholtz**

As best as I as can remember, this will be the first "official" visit to the SLN faithful for State Senator Sara Feigenholtz. Ms. Feigenholtz was elected in November 2020, to take over the position held by long-time State Senator John Cullerton who retired. We are all familiar with Senator Feigenholtz as she was the State Rep. for the 12<sup>th</sup> District since 1994 which is the District next to ours.

### 3015-17 N. Lincoln Ave - Repurposing and Zoning Change

This building is fronted on Lincoln Ave. with the window ad for Char-Crust (by appointment only) and the awning over the stairwell entrance that says "Lake View Lofts." The back of the building extends to Greenview Ave. Currently, you have the mysterious Char-Crust in the commercial space and there are 6-8 rental apartments on floors #2 and #3.

The prospective buyer is Brian Zucker, the founder and president of Human Capital Research Corporation (HCRC). Established in 1991, HCRC provides strategic and tactical information to college and university leaders, administrators and policy makers. Mr. Zucker is looking to relocate the HCRC business operations from Evanston to Lincoln Ave. The building will stay intact. This will be a total gut-rehab with the three floors redesigned as office space. No rental or condominium units. However, Mr. Zucker will incorporate a "city apartment" for himself into the design.

The building is currently zoned B1-2, normal for that span of Lincoln Ave. Because the rehab will include replacing the current old freight elevator with a new code-compliant elevator and a roof deck, an elevator penthouse structure is required and an enclosed stairwell will be added to the 3rd floor, increasing the overall height and the allowable total square footage of the building. In order to accommodate these changes, a zoning change to B1-5 is required. HCRC expects 30 employees to work from this building with another 12-15 positions being added in the next two years. HCRC expects almost all of the employees to use public transportation or bikes to get to work. There will only be two indoor parking spots in the building off the alley behind Lincoln Ave. This will require a parking variation under the Transit-Oriented Development (TOD) guidelines.

SLN's Neighborhood Development and Review Committee (NDRC) has lined-up some of the pros and cons of the project.

Pros: rehab of older building, avoidance of another knockdown with an unrentable commercial space and increased foot traffic for area businesses from the 30-45 employees.

Cons: increased parking or traffic congestion from the employees, loss of rental units and B1-5 zoning which would allow for some dense activities if the building was ever sold.

Regarding the zoning issue, the NDRC is working with the Alderman on the possibility of down-zoning the property after the rehab is complete or entering into a restrictive covenant regarding the types of operations allowed.

This will be SLN's first ZOOM voting issue. We (Steve Stern) are working on it.

The immediate area will be flyered.

The results will be forwarded to the Alderman.

### Northwestern Medicine Immediate Care - Lakeview 1333 W. Belmont

A representative of Northwestern Medicine will update the SLN members as to the medical services available at the 1333 W. Belmont offices.

### New Business – Rica Arepa Venezuelan Restaurant @ 2913 N. Lincoln

The owners will give an overview of the menu and operations of this recently opened restaurant. This is the 2<sup>nd</sup> location (4253 W. Armitage) for these owners. Big deck in the back for outdoor dining.

#### AT THE MARCH 2021 MEETING

The upside to the ZOOM monthly meetings has been the increased availability of our elected officials to give more frequent "in person" ZOOM updates as to what is happening nation, state and city-wide. The biggest down-side to the ZOOM is the well-noted decrease in the attendance by the reliable in-person senior SLN members and the before and after socializing that allows you to meet your concerned neighbors. Anyway, here is what happened at the March ZOOM Meeting.

#### **Congressman Mike Quigley**

Congressman Quigley informed the SLN membership that he attended his first SLN meeting in 1982. He would have been 24 years old then and probably working for Alderman Bernie Hansen.

The Congressman told us that Congress was voting on an issue that night and the following morning was the vote for President Biden's Stimulus Package. He noted that since he last presented to SLN in October 2020, there was an election, an insurrection and the rolling-out of the Covid-19 vaccine. He acknowledged tremendous suffering that has occurred during the Pandemic. The \$1.9 trillion Relief Package is a number. Some numbers staggering Congressman threw out were \$7.5 billion coming to the State of Illinois as all areas of State revenue have decrease, \$1.8 billion coming to the CTA and the RTA to relieve the economic pressure caused by reduced ridership. \$400 billion is going to be divvied up among the States to fight the Pandemic and get people vaccinated. \$40 billion is earmarked for higher education needs.

Congressman Quigley said the next big thing on Washington's agenda is an Infrastructure Package. He said this is not going to be like our parent's infrastructure bills. It intends to include money for roads, bridges and parks but will also include money for climate change issues, rebuilding the Lake Michigan lakefront and improving the digital divide issues that affect the USA.

Other issues to be tackled is some kind of Gun Control legislation (this prior to the Atlanta and Boulder, CO. mass shootings) and a Voting Rights Act bill.

Regarding Postal Service issues, the Congressman is working on some improvements. He noted that during the Pandemic, letter mail volume was down

but package delivery was way up and the Post Office could not handle that increase. He said that the Pandemic caused a 50% increase in postal workers not showing up for a variety of reasons, but one being having to stay home as the mail workers children had to do virtual learning. The Congressman said this a broader National issue and not just a Chicago area issue. He finished by saying that the former President Trump Postmaster General tanked while in that position.

Congressman Quigley commented at the end of the meeting that if the GOP is going to filibuster every legislative action, the Democrats will try to change that rule. See next article on what a filibuster is.

#### What is a Filibuster?

The term "filibuster" comes from the French "flibustier" word meaning "pillaging pirate." In terms of parliamentary procedure, the word was not used until the 19th century However, the use of long speeches as a delaying tactic is part of the history of the Roman Senate.

The filibuster is a tactic used in the U.S, Senate to block or delay action on a bill or other measure. A filibustering senator may endlessly debate an issue, introduce time-consuming procedural motions, or use any other means to obstruct or prevent action. Senators have done everything from reading Shakespeare to reciting the Constitution to hold the Senate floor.

The Senate can overcome a filibuster if it invokes cloture – a vote by 60 members of the Senate to place a 30-hour time limit on consideration of a bill or other matter.

Cloture, adopted as Rule 22 in 1917, used to require a two-thirds majority vote. However, due to the difficulty of obtaining a two-thirds vote, the Senate changed the rule in 1975 and reduced the number of votes required to three-fifths (or 60).

In recent days there has been talk by some Democratic Senators of getting rid of the filibuster and passing legislature with just a simple majority. The Republican Senators, and some Democrats, are against this. So there is talk of reinstating the talking filibuster. It makes senators who want to hold up legislation actually put their mouths where their votes are — at length, but then grants an "up or down" simple majority vote if they give up.

First, it would make obstructive use of the filibuster more costly to use, and therefore hopefully more rare, deterring frivolous filibusters and give the minority an incentive to conserve its use for the issues of greatest import.

Second, a talking filibuster would also make obstruction more transparent. Instead of quietly filing their objections with the Majority Leader's office, filibustering senators would have to publicly defend their position over multiple days and expose their arguments to public scrutiny.

The big drawback, though, is that all that talking could be used for other purposes by the opposition.

#### State Rep. Ann Williams

State Rep. Williams started out her presentation by telling the SLN members that the State is finally transitioning from all Covid-19 Pandemic issues and is now considering non-Pandemic issues. Though in-person meetings have started at the Capitol, Ms. Williams said all Committee meetings are still being held remotely by ZOOM.

Ms. Williams said the State is trying to deal with the Illinois Department of Employment Security (IDES) issues, from the lack of service due to the massive sudden increase in claims due to the Pandemic, to false claims and identity theft. She noted that the IDES software is antiquated and that the general service needs to vastly improve. She said that the Lakeview area unemployment numbers were much lower than other Chicago and State areas.

Ms. Williams made a general comment that "big dollars" are coming from the Federal government to the State of Illinois and that will help things out.

Ms. Williams did throw her hat into the ring for the Speaker of House vacated by Mike Madigan. Though she eventually withdrew, she is happy with the new Speaker of the House - Rep. Chris Welch. She said she is seeing more political activity since the change and revealed that Mr. Welch does have a cell phone that can be called, as Mr. Madigan did not have a cell phone.

On the subject of Chicago area school reopenings, Ms. Williams said it has been difficult working with the various Community Organizations, CPS and the Chicago Teacher's Union. She noted that the community is torn on the issues and solutions,

though all are basically in agreement of the need to have a stable school environment. She took a question from an SLN member on whether there is any movement on requiring five-day school week and the exodus of students from CPS due to that issue. She commented that she had not heard anything at that time and is not easy to explain the algorithms used for predicting potential virus spread. Ms. Williams stated that she supports an elected School Board. She also noted that the school funding formula was changed a few years ago and is less reliant on property taxes and is more reliant on direct funding from the State.

#### **New Businesses:**

#### Dear Margaret - 2965 N. Lincoln

Owner Lacey Irby presented an overview of her newly opened restaurant. Dear Margaret features local Midwest ingredients in her French-Canadian cuisine. A French-Canadian cuisine focuses on ingredients that are available in this moment, cooked with a balance of comfort, necessity, care and sometimes indulgence. Chef Ryan Brosseau spent his childhood in southern Ontario where the emphasis on cooking makes use of the whole animal, canning and preserving and having very little food waste. Lacey commented that recently the restaurant brought in a whole lamb and used different cuts for their menu items. Margaret is Chef Brosseau's French Canadian meme' (grandmother). Currently open for carryout only. She believes that indoor dining will occur most likely after Chicago enters Phase 5 of reopening from Covid-19. They are working on getting a street café permit. For more info see www.dearmargaretchi.com.

Steve Stern, SLN corresponding secretary, had the braised beef shank and gave it a rave review.

### Ann Williams, State Representative, 11<sup>th</sup> District Spring Legislative Update

From State Rep Williams's recent email, here what's happening in the 11th District and in Springfield.

In addition to chairing the Energy & Environment committee, I serve on the Judiciary-Civil, Ethics & Elections, and Tourism committees this session. These committee appointments represent a broad spectrum of the work to be done in Illinois, and I look forward to working with all of my colleagues on these issues and the many others that impact Illinois families and communities.

During the course of the pandemic, I was a strong advocate for creating a remote voting plan for the General Assembly, and introduced legislation on the topic. The House is now working using a hybrid plan - where committee hearings meet remotely and legislative floor action takes place in person.

Along with a diverse group of legislators - including more than 50 percent women in the House Democratic Caucus - and a new Speaker of the House, we continue to focus on issues including COVID recovery, support for small business, economic stability, equity and much more. I have reintroduced the Clean Energy Jobs Act (CEJA), a comprehensive energy package that addresses climate change, provides for job creation and the development of renewable energy sources, and holds utilities accountable in the wake of the farreaching ComEd corruption scandal.


