Single-Family House Development of Vacant Lots at Wolfram and Paulina – 18 Single Family Homes

A Developer will present plans for the development of the vacant land at the northeast corner (currently fenced in) and southeast corner (backside of Fertile Urban Gardener) located at Wolfram and Paulina. The Developer is proposing building 13 RT-4 zoned homes (extra large) on the north side of Wolfram Ave. that will be 3-levels with a private alley and five RS-3 (the size allowable east of Lincoln Ave.) homes on the south side of Wolfram Ave.

Part of this land has been previously developed next to backside of The Jewel with high-end singlefamily homes and a private pool!

The Developer requests a zoning change from the M-Manufacturing zoning to the required R-Residential zoning. This will be a voting issues for all SLN members and the neighboring residents. The immediate area will be flyered by SLN.

A Little History of this Area.

Until the 1980's the area within Diversey/Paulina/Wellington and Wolcott was the site of some of the largest factories in Chicago. The Stewart-Warner factory located at 1826 W. Diversey Parkway is now the site of two townhome developments on Diversey and Wolcott spanning to Oakdale. Stewart-Warner was a 6-story factory that during and after WWII, was one of Chicago's largest employers with 8,000 employees at its' peak. The large factory was easily visible along with the St. Alphonsus Church steeple from the Hancock Observatory Deck. Appleton Electric at 1701 W. Wellington was operating until 1986 when it moved to Columbus, NE. along with its 500 jobs. The site is now the row of white townhomes at

Wellington and Paulina continuing to the townhomes along and west of Paulina. The closing of these factories brought an end to the era when many people in the area lived near the factories where they worked.

Fertile – Urban Garden Center 1646 W. Diversey Parkway

Owner and SLN Member - Susan Brandstetter will give a Spring planting presentation to the SLN Membership. Fertile caters to the urban gardener, homeowner and landscape contractor.

AT THE APRIL 2021 MEETING

State Senator Sara Feigenholtz

Ms. Feigenholtz was elected State Senator for the 6th District in November 2019 and joined the Illinois State Senate in January 2020. The 6th District encompasses Lakeview, Lincoln Park, Roscoe Village, North Center, Ravenswood Manor, Bucktown and Albany Park. Prior to that, Senator Feigenholtz served as a State Rep. for the 12th District since 1994, which is the District next to ours.

The Illinois Government went on Covid-19 lockdown shorty after she arrived in Springfield. Now is the first time all the elected officials are back in Springfield since then. During that time almost all the elected officials time was spent on managing the Pandemic.

The Senator is the chairperson of the Hospitality Committee and is working on some reforms and revenue streams for small businesses, restaurants and the State's convention business that was devastated by the Pandemic. She helped pass the "cocktail to go" bill that allowed bars and restaurants to sell carry-out alcoholic drinks. She also sits on the Human Services, Appropriations, Environment and Conservation and Licensed Activities committees.

Things the Senator has or is working on:

Housing – to build more affordable housing in Illinois.

Nurse Compact Bill – which allows nurses to work across State lines.

Landlord Bill - \$585 million has already been awarded renters who lost jobs during the Pandemic

and \$560 million is available for lost rent that would go directly to the landlords.

Real Estate Assessment Reduction – a reduction for landlords that keep rents low and affordable for their renters.

3015-17 N. Lincoln Ave – Repurposing and Zoning Change

Human Capital Research Corporation (HCRC) is looking to move its business operations from Evanston to this building. HCRC was represented by its owner Brian Zucker and HCRC's real estate attorney and architect for the Project. HCRC's attorney described the Project as a repurposing of a building that is not really that inviting to look at into a totally gut-rehabbed building with all modern upgrades in order to house a successful small business in the SLN neighborhood.

HCRC's owner, Brian Zucker gave a description of the business. He described it as a business that is off the beaten path. HCRC was established in 1991 and provides strategic and tactical information to college and university leaders, administrators and policy makers. Mr. Zucker stated that he is in this business because he sees higher education as an agent for economic and social growth, but that higher education has to be accessible and affordable. Currently, HCRC is a \$9 million company whose growth has come by client (university/college) retention and by word-of-mouth. He felt that HCRC is like a family business and noting that the employees work and socialize together. Mr. Zucker said this particular building was chosen because HCRC wanted an office building in a neighborhood, accessible by public or bike transportation and that HCRC wanted to become part of the neighborhood by eating, shopping and socializing in that neighborhood. Mr. Zucker said HCRC currently has 30 employees and expects to grow to about 45 in the next two years.

The HCRC architect came on to describe the Project. He described the building as fronted on Lincoln Ave. with the window ad for Char-Crust and the awning over the stairwell entrance that

says "Lake View Lofts." The back of the building extends to Greenview Ave. Currently, there are 6-8 rental apartments on floors #2 and #3. The whole façade of the building will be cleaned-up and windows will be added to the 3rd floor, which will include Mr. Zucker's living residence. The basement will be dug-out to provide modern systems to the building. The 1st and 2nd floors will be converted into office space. The 3rd floor will be converted into office and meeting spaces and as previously noted Mr. Zucker's residence. The roof will have structures that enclose the buildings mechanicals, the stairwell enclosure to the roof and the enclosure for the new ADA compliant elevator being put in. All and all, the architect said the final Project will be a brand-new building in the skin of an old building (built in 1905). However, the architect finished up by stating that renovations will require an up-zoning from the current normal Lincoln Ave. zoning of B1-2 to B1-5. He then added that HCRC is fully committed to down-zoning the Project back to B1-2 after all the rehab is completed and that the HCRC attorneys are working on how that will take place. Construction would start in December 2021 and be completed in the Summer of 2022.

At that point, Sam Samatas, chair of the SLN Neighborhood Development and Review Committee (NDRC) took the floor. Sam said the NDRC was concerned by the zoning upgrade request setting a precedent for future developers, but that issue was satisfied by the down-zoning commitment by HCRC. A potential congestion issue was placated by the HCRC report that 75% of the employees will take public transportation or bike or walk to work. Sam concluded that the NRDC liked the economic benefit HCRC would give to the immediate area. The NDRC endorsed the Project.

This was SLN's first voting issue on ZOOM. Normally a private paper ballot is used at the inperson meetings. First, we tried the "thumbs up" icon, which some people could not find. Then we tried the green check-mark on the side of your screen. Some others could not find that. Just like a Progressive Insurance commercial where we are becoming our parents. We settled on just having anyone opposed the Project to voice a NO vote. There was one objection. So, the Project was approved with one objection. The results were forwarded to Alderman Waguespack's office.

Northwestern Medicine Immediate Care -Lakeview 1333 W. Belmont

Northwestern Medicine Immediate Care has been in existence on Belmont for over 10 years now. The Operations Manager and the Practitioner Manager presented to the SLN members as to the general operations within the Building. The Immediate Care area is open 12 hours a day, 7 days a week from 8AM-8PM. No appointment is necessary. They are able to treat minor illnesses and accidents plus skin conditions. They offer vaccinations, x-rays and lab tests. The representative noted that the Immediate Care area is great for when you have some type of normal illness and you cannot get to your regular doctor. The Immediate Care area is not for emergencies and they will refer you to an Emergency ward if required. Northwestern Medicine has 22 total Immediate Care sites throughout the Chicagoland area. The 2nd and 3rd floors of the Building are doctor offices offering primary care medical services and a variety of specialty care doctors in pediatric and dietician offices. The 3rd floor of the building has MRI and Xray services. A parking garage is located on onsite. For more detailed information or to schedule an appointment the Rep referred us to visit the website at: Nm.org.

NEIGHBORHOOD TIDBITS

I have covered a lot of territory walking around the neighborhood during the Pandemic. Way more on the side streets than usual, as there were no real people watching to do on the main streets. I recommend taking walks and look up at the top of the older buildings in the neighborhood to see the intricate designs located at the roof lines of the buildings, especially the 2 and 3 flats.

Coffee Lab at 2823 N. Lincoln. Sign on the door says "Going tipless. Menu prices will be modestly increased. Our employees will be paid a fair and consistent wage."

New business The Blend Barber at 2735A Lincoln. Classic haircuts. Haircut \$37. Hot shave \$40. I guess you get what you pay for. 3 chairs.


