Wow! Fall sure hit me on Sept. 21. After wearing shorts all summer, long pants are now in order. Weather change in Chicago is always dramatic.

Covid is still with us. The Delta variant is quite dangerous. Please get vaccinated, if you have not yet. In areas where Covid is rampant, hospitals are filled with unvaccinated patients. Vaccinations are available from your physician or local pharmacies. Some of us are eligible for a booster, as well. While positivity rates are going up in some areas, Chicago's rate is dropping, due to our higher vaccination rates and adherence to masking guidelines. When I have traveled to other states and other countries, I have found that there is a perception that people from Chicago are "smart". (I

Schools are open again and in-person learning has resumed. Hopefully, safety precautions will keep infections and quarantines to a minimum. There may soon be approval for 5-12 year-olds to be vaccinated, which will make our schools even safer.

Next month Congressman Mike Quigley will speak at the Oct. 5th membership meeting. At our Sept. 7th meeting, Alderman Scott Waguespack presented on the "state of the 32nd Ward". One question he received concerned rising property taxes, more of a Cook County issue. We hope to have Cook County

Assessor, Fritz Kaegi, present at a future meeting. Chicago did pass a new budget, which is fairly progressive and addresses some of our neediest citizens. This reminds me that it is always a good time to donate to the Lakeview Food Pantry. Chicago is also developing a new ward map. Hopefully, any changes will not impact the 32nd Ward under Ald. Waguespack.

And a shout-out to the Illinois State legislature for the recent passage of a "clean energy" bill. This bill supports green energy, while phasing out coal and other fossil fuels. Reports suggest that the Illinois bill could be a model for other states, particularly vital in this period of climate change.

My final comment relates to one of our local newspapers that constantly states that people are leaving Chicago and Illinois. The reality is that the population of Chicago has slightly increased. Yes, our taxes are problematic. But when I see the insanity existing in some other states, I am pleased to live in Chicago, Illinois where our mayor and governor care as much about my health as they do about their positions.

Don't forget to patronize our local businesses. Make it a point to get at least one meal this week from one of the great eating establishments in our neighborhood.

AT THE SEPTEMBER 2021 MEETING

Due to COVID-19, of course, SLN's last in-person meeting was held in March 2020. We were successful in holding ZOOM Membership Meetings from September 2020 to May 2021. The Board felt it was time to go LIVE, so SLN held its first in-person meeting on Tuesday, September 7.

Since 1964 (the inception of SLN), the SLN Membership Meetings have been held on the 2nd Tuesday of the month. In order to use the large auditorium at The Athenaeum and promote safe, social distancing, the September meeting and the remaining meetings in 2021 will be held the first Tuesday of the month as that is when the big auditorium is available.

Needless to say, we were a little rusty in getting a live meeting going. The normal group of SLN officers and directors that get a live meeting running consists of the current President Bob Blitstein and officers Steve Stern, Sam Samatas, Bill Haderlein and Fionn McManigal (excused due to the birth of baby #2). Unlike at the ZOOM meetings, we had to check to see if we had bad breath, put on deodorant and change clothes, well sort of. We forgot to set up a sign-in table and have membership renewal forms available. At the last second, we were asked if we wanted the U.S. flag and SLN banner put up on stage. We passed on that due to the last-minute hassle factor. However, we did plan to have extra face masks in case someone forgot theirs (not needed). So, the members filed in with masks on. It was hard to recognize and understand the names of people signing in; but at least we didn't have any fights,

arguments or protests about the mask mandate as has been taking place on airplanes and New York City restaurants, despite the fact that alcohol was available at the Theatre's little lobby bar. As the start time of 7:00PM had passed and the scheduled speaker Alderman Waguespack had not arrived, we wondered if the Alderman thought it might be a ZOOM meeting. The Alderman arrived a little late and the meeting began. We just sucked it up and said the Pledge of Allegiance to a make-believe flag.

Alderman Waguespack – State of Ward/City presentation

As the podium was a safe distance from the attendees, the Alderman took his mask off to address the crowd. Here is recap of the topics he covered (additional information based on his presentation appears in *italics*).

LOCAL ISSUES:

Lincoln Ave. Water Main Project:

Businesses are open and alerted when water shut-off issues occur. When the Project is complete, he believes the landscaping of Lincoln Ave. will commence. He will reach out to SLN at that time for our input. However, he indicated that once landscaping is installed, the maintenance of green items like trees or flower boxes becomes the responsibility of the neighborhood, businesses or the Chamber. The City cannot manage spot landscaping projects.

Vacant Space at the Red Hot Ranch strip mall – a Taco restaurant is planning to move in.

Tatas and Tacos on Lincoln Ave. – has applied for a PPA license (Public Place of Amusement) in order to have live music.

Dinner and a Movie at Altgeld & Ashland – The Alderman said the business is closed and under examination for various offences. *Block Club reports that neighbors had been complaining about the business not operating as a restaurant per their license. On June 27, there was a fight that started inside and spilled outside. At that point, a man got out of car and fired about 17 shots toward the business. No one was hit. Police Commander Papaioannou reports the police have responded to several calls about the establishment.*

CRIME:

The Alderman recapped recent the recent crime pattern as down at the beginning of the Pandemic. Then crime started to increase including the rioting and looting associated with the George Floyd protests in June 2020 followed by the mass looting

of Michigan Ave., Gold Coast and Lincoln Park stores in August 2020. Now trends have theft and sexual assaults up in the 19th District. Assaults are up in the Downtown and River North areas (as evidenced by TV and newspaper reporting). The Alderman also commented on the crazy driving that has occurred during the Pandemic such as severe speeding, driving on expressway shoulders and driving on Ashland Ave. medians, U-turns and fire hydrant parking.

The Alderman admitted that Police numbers are down and Police morale is down. Veteran police are retiring and recruiting new officers is a challenge in these anti-police times. He estimated that the 19th District is 15% below the desired manpower. The 19th District is budgeted for around 400 officers and currently has 308. The shortage was evident before the merger of Districts and officers are being deployed Downtown and to high crime districts. Additionally, he cited the lack of prosecutions by the States Attorney and the courts being closed during the Pandemic and violent criminals were being let out of jail pending their trial. The Alderman did note that an 8-year contract was ready to be approved by the City Council. That contract was five years overdue.

He wrapped up the crime section of his talk stating that he speaks frequently with the CPD Command staff and hopes to solve some of the problems with better deployment of officers. His office is working with the CPD to crack down on bad businesses and bad property owners and is looking to stiffen fines for certain types of crime.

ZONING ISSUES:

3122 N. Ashland – Swedish Covenant is renovating the space and putting in an Immediate Care facility.

1534 W. Barry City Parking Lot – advertised in the Inside Booster as being for sale. This is possible, but he is not giving that space away and will be working with SLN and its' NDRC committee when a realistic proposal is presented. He commented that Developers are looking to connect that Development to the buildings on the north east corner of Ashland and Barry.

3128 N. Greenview Parking Lot - the Lakeview Chamber has inquired as to the possibility of putting a dog park in the parking lot.

Ashland/Barry Parking Lot – nothing happening at this time. A large apartment building complex plan had previously been floated around SLN and the NDRC.

Wolfram and Paulina 18 single family homes – he supports the project (as voted on at the SLN May 2021 ZOOM meeting). He realizes that any new development within the Burley School boundaries will impact the capacity limits at the school.

Urban Forestry Advisory Board – in June 2021, the City Council voted to create this Advisory Board. Alderman Waguespack was one of the lead sponsors of this Board. The main purpose of the Board is to increase the City's tree canopy for environmental purposes. *It is reported that Chicago removed 10,000 street trees per year from 2010 to 2020. A study by The Morton Arboretum showed a 19% decrease in the City's tree canopy due to storms, pests and development.*

BUDGET:

There is a \$700,000,000 deficit in the current City Budget. The good news is that deficit is before funds to be received under the Federal Government's American Rescue Plan (ARP) which is a plan for guaranteed direct relief to cities, towns and villages.

PARK DISTRICT LIFE GUARD HARRASMENT ISSUE:

The Alderman reported that this behavior has been going on for several decades. He said the investigation is going deeper than it appears on the TV news or the newspapers. The Investigator on the issue was fired by the Park District claiming retaliation. The City is working with that investigator on that issue. The Alderman reports that dozens of Park District employees have come forward in this investigation.

WARD REDISTRICTING:

In conjunction with the 2020 Census, the City is required to remap the 50 Chicago Wards. The Alderman stated that the average population per Ward should be around 54,000 per Ward. The Latino caucus has gained power with their population increase and the Black caucus lost 180,000 in population over the 10-year period. The Alderman believes his 32nd Ward may encompass more areas to the east of the current boundary as the Lakefront Ward population has increased and will have to give up some blocks. Currently, SLN is in the far northeast corner of the 32nd Ward. At one time, SLN was in the Lakefront's 44th Ward now represented by Tom Tunney. When SLN was last in the 44th Ward the recently deceased Bernie Hansen was the Alderman. The Alderman noted

that the remapping must follow Federal Voting Rights Guidelines.

SLN would like to thank Alderman Waguespack for his continued support of the SLN meetings and his continued work with SLN's Neighborhood Development and Review Committee.

From Congressman's Quigley 9/16/2021 email message:

The Congressman has led six climate change tours of U.S. National Parks. In early September 2021, Congressman Quigley led his colleagues in the Sustainable Energy and Environment Coalition on a three-day tour of Acadia National Park in Bangor, Maine. Here is a summary of his observations in Acadia:

- 1) Native plants and trees are struggling to adapt to changing temperatures. Previously, trees could drop seeds that grew up at the same pace as old trees died, but now as the

old trees die, invasive species take over before the new trees catch up.

- 2) Six years ago, scientists at Acadia discovered an invasive Japanese insect attacking the native red pines. Now, almost all the red pines in Acadia are dead. Warmer weather allows the invasive insects to now survive winters and reproduce, causing greater harm to the red pines.
- 3) Scientists have noticed that sea gull populations are in decline, with fewer eggs being laid and fewer fledgling surviving.
- 4) The Park staff's understanding of the science of climate change and its impacts - rising sea levels and shifting growing seasons for crucial native plants - is crucial in tackling the climate crises.

Finally, Congressman endorsed President Biden's "Build Back Better Plan," which includes critical initiatives relating to climate change. He felt that after "seeing the beauty of Acadia, it has never been more clear to me that climate actions cannot wait."
