A lot of changes are coming to the Chicago Public Schools. A new funding formula will hopefully provide more equity and more resources for schools. Public schools within South Lakeview also depend on parent fund raising efforts. Burley, Tubman and Jahn, as well as St. Alphonsus, rely heavily on parent financial support. Contact your

local school if you want to donate and help some neighborhood children. The public schools will hold their LSC (Local School Council) elections on April 10 (Apr. 11 for high schools). If you live within the attendance area of a school, you can vote. The LSC selects the school's principal and approves the

yearly budget for each school. In addition, this year the Chicago Board of Education will transition to an elected board, instead of mayoral appointment. This year 10 members will be appointed by the mayor and 10 elected. Eventually, all members will be elected. Even if you are not a parent of schoolaged children, the success of our schools correlates directly to the success of Chicago.

My favorite State Representative, Ann Williams, presented at our Feb. membership meeting. She addressed state efforts on tech safety, budget issues related to the end of federal funding and how Illinois might address the influx of migrants. And, Ann has led the effort to design an election map for the Chicago Board of Education elections, a daunting task considering fair representation for the diverse constituencies in Chicago.

I feel in South Lakeview, we are blessed to be served by politicians who are responsive to our requests and needs. This doesn't mean that all of our issues are addressed the way we'd like, but the efforts and the results are often there. A shout-out to Alderman Scott Waguespack, St. Rep. Ann Williams, St. Sen. Sara Feigenholz, Cook County Commissioner Bridget Degnan, and U.S. Rep. Mike Quigley. And yes, they are busy, but be persistent and they'll answer your call.

Lastly, an involved zoning issue for a development on Lincoln Ave. was presented and approved. New TOD (transit-oriented development) rules and a state proposal to prohibit neighborhoods and towns from limiting new developments to single-family homes are all aimed at increasing the number of housing units and increased density. Though many do not want increased density in South Lakeview, we must be aware that this will happen, especially with the demand for housing so great. And remember those who are homeless and live in substandard housing, and reflect on how fortunate most of us in South Lakeview are.

By the way, last weekend my wife and I were driving through near north, downtown, west loop and the near southside. We couldn't help but notice all of the new buildings going up. So the next time you read about how people are leaving the city in droves, there are a lot of developers that think Chicago has a vibrant future. So do I!

MARCH 2024 MEMBERSHIP MEETING – PREVIEW

Chicago Police Department – CAPS Sgt. Angelo

CAPS (Chicago Alternative Policing Strategy) representative Sgt. Angelo will present 19th District and SLN area crime statistics, discuss policing strategy and take questions from the Membership. Sgt. Angelo is making a special visit to the SLN meeting upon his normal CAPS meetings and duties.

Mayor's Office of Community Engagement

1st Deputy Sara Mathers of the Mayor's Office of Community Engagement will make a first-time presentation to the SLN membership. This Office is the first line of communication between neighborhood groups, communities and citizens and the Mayor's Office. Get Ready.

Cook County States Attorney – Democratic Primary Candidate drop-ins

SLN has invited candidates for this contested Primary Election to drop-in to state their platform. As the candidates' election schedules are always in flux, we may not know which candidate will attend until the day of the Meeting.

AT the FEBRUARY 2024 MEETING

Happy 100th Birthday – Rudy Karall

SLN members, family and friends celebrated the 100th birthday of long-time SLN member and

Lakeview resident Rudy Karall. The bar was open and SLN supplied a birthday cake. The SLN meeting started with Rudy, a WWII veteran, doing a little dance then leading the membership in the Pledge of Allegiance followed by a rousing rendition of Happy Birthday to Rudy. Rudy thanked the membership and gave us his recipe for a long, healthy and happy life. They are the 4F's – Faith, Family, Friends and Food. Remember that.

State Rep. Ann Williams – legislative updateState Rep. Williams is currently serving her 7th term as State Representative of the 11th District. Ann currently chairs the Energy and Environment Committee and serves as Vice-Chair of the Judiciary-Civil Committee. Ann is a leader on issues related to the environment and was the chief House sponsor of the Clean Energy Jobs Act.

Ms. Williams started her presentation noting that since being elected, she has been interacting with some of same SLN members she met when she was first elected.

PUBLIC SAFETY- she noted that while the State is not directly involved in the day-to-day operations on law enforcement, the State has been directing funds for new technology, such as license plate readers on Lake Shore Drive to help solve various crimes.

NEW SPEAKER of the HOUSE - with Mike Madigan no longer controlling the Floor operations with an iron hand (1983-2020), she noted that the new Speaker of the House Chris Welch's process to promote legislation is by assigning "working groups" to address the issues.

ELECTED SCHOOL BOARDS - Ms. Williams is on the Elected School Board group. They are in charge of implementing the transition of the State of Illinois appointed School Boards to elected Boards. She described that the Board will start out with ½ elected members and ½ appointed members. Then by the following election, 100% of the Board will be elected. She said the Districts and Maps are still being worked on.

OPEN MEETINGS ACT - due to provisions of quorum rules (e.g. 5-member committee has a 3-member quorum) stating that people (voters) have a right to be informed if a quorum of a committee meets, the newly created Chicago Police District

Councils consisting of 3 members have had logistic issues in meetings as 2 members would be a quorum and require a public meeting. So, if two Police District Council members met with a Police Commander, that would be public meeting that would have to be advertised. Ms. Williams is on a committee to adjust this provision to allow the District Council members some relief of this onerous provision on a smaller committee.

BUDGET – \$53 billion budget with a \$900 million shortfall was just announced by the Governor. State Rep. Williams declared that the State is currently flush with Federal Funds. However, she noted that is coming to an end and there will be critical budget issues that will need to be addressed in the coming years.

PUBLIC TRANSPORTAION - still a big State Budget priority.

MIGRANT ISSUES: Ms. Williams stated that traditionally, the Federal or State governments were not in business of supporting migrants. However, the unprecedented wave of migrants starting in late 2022, put pressure on the government to provide humanitarian aid. The hope is to get the migrants up and running and then they will get jobs, housing etc. and be able to fend for themselves. But she admitted that she does not see how this situation is going to end in the near future.

3036 N. Lincoln – proposal for Transit Oriented Development (TOD), 16 rental units with 7 parking spaces. Zoning upgrade request.

THE DEVELOPER: Envoi Partners is the Developer. Per their website, Envoi is defined as "a short final stanza of a ballad serving as a summary or dedication." The partners are Nate Ernst, who was the presenter at the meeting and Cory Faulkner. They were also represented by their attorney.

PROPERTY/BUILDING FACTS: This is a 4-story, commercial building that most recently had the Wrightwood Furniture Co. as the ground floor tenant. The Property is lot-line to lot-line with 50ft. on Lincoln Ave and 125ft. deep. The Property and almost all of the 3000 block of Lincoln is zoned B1-2. The current zoning allows for commercial on the ground floor and basement and a total of 6 residential units on floors 2-3-4 (i.e. two 3,000 sq.ft units per floor). It was built in 1917. The Property is totally vacant. All four floors are unfinished open floors with no walls. Though the exterior of building is brick, all the interior support posts are made of wood. In general, the interior of the Property is in total disrepair.

REDEVELOPMENT ISSUE: This is an older non-conforming, over-sized, box-like Building with the current zoning allowing for only the 6 dwelling units total. All parties (Developer and SLN's NDRC) find that this layout is not realistic from a market and financial viewpoint. The goal is to repurpose this Building with more but smaller units and having some off-street parking.

PREVIOUS DEVELOPER PROPOSALS: The Developer has the Property under contract contingent on receiving a zoning upgrade to B3-3, in order to achieve their Development goals of more Units and to better market the commercial space, for example a restaurant that serves liquor. The Developer intends to redevelop this Property under the City of Chicago's Transit Oriented Development ("TOD") Expansion Ordinance.

Developer Proposal #1 - commercial space on the 1st floor and basement and 22 rental units of various sizes (mostly Studios and 1 bedrooms with a few 2-3 bedroom units) on floors 2-3-4. No parking spaces for tenants. This proposal was rejected by SLN's NDRC.

Developer Proposal #2 - commercial on 1st floor and basement. Floors 2-4 will have 16 rental units consisting of a variety of studio and 1-2-3 bedrooms Three tenant parking spaces in the back of the Property. This proposal was also rejected by SLN's NDRC.

Developer Proposal #3 (as presented at the SLN meeting by Nate Ernst) - commercial on 1st floor. Floors 2-3-4 will have 16 rental units. Floors 2-3 will have 4 1-bedroom and 2 2-bedroom units. Floor 4

will have 2 2-bedroom units and 2 3-bedroom units. Parking - a ramp will be built to the basement for 6 parking spaces and 1 handicap space will be located at the back at ground level. 17 bike parking spaces will be located in the basement. Recessed dumpsters will not be in the alley. Due to the size of the Development, 3 units (15%) will be marketed as Affordable Units with lower rents. The Development will be fully-sprinklered up to the highest fire code. Estimated rents would be \$2,000 for 1 bedrooms, \$3,000 for 2 bedrooms and \$4,000 for 3 bedrooms.

The Developer intends to own and operate the Property after the redevelopment.

Mr. Ernst for Envoi Partners stated that they are in the business of taking older buildings and repurposing them as rental properties. They work and live in the area. One of their recent projects is at 3546 N. Southport. They feel the finalized Lincoln Ave. streetscape with its new wide sidewalks is ready for "right-sized" retail or a higher-end restaurant. They were attracted to the unfinished interior of the Property which will allow them to develop a variety of unit sizes. They were impressed with the massive front windows and the view out onto Lincoln Ave. Nate indicated that the Proposal has been a product of working with the SLN. neighborhood group. He also indicated that though they increased the off-street parking in Proposal #3 as suggested by SLN's NDRC, he felt that the TOD Development will not use all the available parking spaces (residents will not have cars).

There was concern from some nearby residents about all the Amazon, UPS and Fed-Ex and Uber delivering that will occur at the building and deliveries to the potential retail or a restaurant. The Developer basically said there is enough space in front and back of the building, but they may look into having a loading area in front.

Sam Samatas, chair of the NDRC, presented to the membership. The NDRC felt that with the 7 parking spaces, this TOD Development is within the 0% to 50% parking requirements. He was concerned with allowing the upgrade to dash 3 (B3-3) zoning as setting a precedent for future Developers. He proposed an upzoning until the retail/restaurant tenant is obtained, then the Property would be rezoned back to B1-2. The Developer agreed to that provision.

A paper ballot vote on the Development as proposed was taken. The results were:

YES in favor - 28

NO opposed – 2

A letter was sent to the Alderman's office with findings of the SLN Meeting and vote.

Please note that the immediate area of 3000 Lincoln Ave., 1400-1500 Barry, 1400-1500 Wellington and 3000 Southport was flyered by SLN announcing the Development Proposal and the SLN meeting.

TRANSIT ORIENTED DEVELOPMENT (TOD):

Transit Oriented Development (TOD) information: Within the SLN boundaries, Ashland Ave. and Lincoln Ave are in TOD designated areas pursuant to the Expansion Ordinance. Under that Ordinance, the City of Chicago expanded the TOD policy to include eight high ridership, high frequency CTA bus corridors to encourage sustainable TOD development near transit and connect communities. Ashland Ave. from Irving Park Road to 95th Street is one of the CTA bus corridors.

TOD Parking requirements:

Under the TOD Ordinance, eligible developments can reduce the required 1:1 parking requirement by 50%, with a 100% parking reduction (zero off-street parking spaces) possible through a Special Use permit from the Zoning Board of Appeals.






