SEPTEMBER 2025 MEMBERSHIP MEETING – PREVIEW

Alderman Scott Waguespack – State of the Ward

The City of Chicago will face a \$982 million budget gap. Will Mayor Johnson fill that gap with a property tax hike? The Alderman will address these fiscal and other issues in his annual State of the Ward address to the SLN membership.

Scott has been SLN's Alderman since 2007. He has been a leading independent voice in the City Council since his election. The Alderman and his staff respect and implement the opinions expressed by SLN on neighborhood zoning and other neighborhood issues.

2804 N. Lakewood – Condo Association as for zoning upgrade from RT-4 to RM-5

Metalworks, the condo association at 2804 N Lakewood, is requesting a zoning change from the RT-4 District to the RM-5 District in order to permit eight (8) private rooftop penthouses to provide acess to private deck space on the building's roof. The penthouses will contain a total of 3,016 sq. ft. of new floor area, which requires the requested zoing change. No other changes or additions are proposed on the two-story condominium building.

The subject property contains twenty (20) residential condominium units with individual unit owners and PINs.

The hardship in this case relates to the existing non-conforming building, and lot conditions. The subject property is improved with a two-story building that was originally constructed lot line to lot line. The two-story building utilizes all of the allowed floor area in the RT-4 zoning district. The unit owners, through their condominium association, are proposing to construct eight (8) rooftop penthouses to provide access to eight (8) private decks on the building's roof. The requested zoning change will account for the floor area contained within each proposed penthouse.

This will be a voting issue.

ANNUAL WALK AROUND THE NEIGHBORHOOD- by Bill Haderlein

It is my impression that people generally do not walk up and down Lincoln Ave. Though I work in the suburbs during the day, I do a fair of walking on Lincoln Ave. in the evening and the weekends to enjoy the super smooth new sidewalks and I do not

encounter much pedestrian traffic. It can be pretty spooky how few people are on the sidewalk on a Sunday night. Some new residential developments are coming on-board and that may improve the people-vibe on Lincoln Ave.. 3037 Lincoln has taken down the protective scaffolding and the work has moved inside. This will add 15-3 bedroom, 2.5 baths to the street. Directly across the street at 3036 Lincoln, work is going on at on the repurposing of the former Wrightwood Furniture business which will result in 16 residential apartments. On 3000 Southport, the condo building with what looks like 3-large units in the Herdegan parking lot moves forward. Someone has been graffitiing this building. That makes me sick. Here is what I noticed during my August 2025 inventory of Lincoln Ave. and other commercial areas with the SLN boundaries.

RESTAURANTS/ EATERIES / BARS:

New SLN area restaurants during the last year are:

- 1) Olive Mountain Grill at 2960 Lincoln
- 2) **Kazka Bakery** at 3056 Lincoln has just opened after having a "coming soon sign" in the window for at least a year,
- 3) **Queen B Coffee** at 3072 Lincoln opened this last year and appears to be popular while Doppio Coffee across the street is still doing good.
- 4) **Southport Betty's** at Southport and George. Super popular since opening. Crowds waiting in line on some nights to get in. I have gone there at 5PM to eat and it was already packed for some reason.
- 5) **Book Club** at Lincoln and George in the old Elbo Room Building. It is a bar/entertainment venue. Open 7 days a week. No food at this time. Go have a drink!

Closed restaurants during the last year:

- 1) Las Tablas at 2942 Lincoln. They were at this site for 19 years and before that they were across the street in a smaller space. They still have their other restaurant on Irving Park near Cicero
- 2) **Tatas Tacos** at 2826 Lincoln. This restaurant was owned by be former SLN resident. They also still have two restaurants on Irving Park also near Cicero. One of which is across the street from Las Tablas.

The Southport Corridor is certainly the headquarters for boutique retail stores. In the last year, Arc'teryx, Vuori and Buck Mason (which was recently featured in the Saturday Wall Street Journal Off Duty special section) have all opened. Nevertheless, businesses are opening on Lincoln Ave. They are more in the service, health or exercise industry.

Foot Reflexology, back pain relief, cupping. Two storefronts down from the Chinese Foot Massage business and across the street from the creepy New Hope Spa that I have seen one person come out in the almost 20 years since I noticed the business.

Maydel at 3118 Lincoln

This is a needlework and embroidery store that is opening 8/20. Looks like you will be able to take classes in golden embroidery, beaded embellishment and darning (like your socks as in the Beatles song Elenor Rigby).

Over at what I will call the L.A. Tan Strip Mall at Ashland and Barry; there is some activity.

Athletic Edge – Training for Youth and the Youthful. Strength-Speed-Agility.

The space on Ashland that had a SLN business presentation for a high-end Thai massage parlor has a new work permit dated 7/28/2025 for Siam Santa

Studio. So, it looks like this mini mall will be fully occupied soon,

Tax and Beyond (a SLN advertiser) has moved from the Sherwin Williams Plaza to a 3013 Ashland. The owner informed me that they have purchased a commercial condo at this space.

Tide Laundromat in the Jewel Plaza- this is a do-ityourself or drop-off laundromat featuring state-of the-art wash machines and dryers.

BUSINESS CLOSINGS:

Barks N' Rec at 3030 Lincoln. This pet store which was in one of the newer Lincoln Ave. condo buildings closed but still has a store in Lincoln Park.

Interior Design Studio at 2946 Lincoln. The handwritten sign in the window says "For Sale- 1 store and 4 apartments.

Addison/Ashland Florist at 3118 Lincoln moved to Bunches (a Flower Shop) on 1501 W. Fullerton. Originally actually at Addison and Ashland when I was kid. Moved to Addison and Ravenswood then to Lincoln Ave. So, they have officially left the Lakeview area.

SOME OTHER THINGS THAT ARE HAPPENING:

Rita Rugs at 3040 Lincoln has had a variety of "Going out of Business" signs for what seems like a couple of years in the window. Now the signs have been updated to include – "Retirement Sale after 45 years. Everything must go. Up to 70% off." Who knows when the official close date will be?

So along with Rita Rugs, already vacant large store fronts on 3000 Lincoln are Brown Elephant, Waxman Candles and Scientology. Chase Bank at Southport and Lincoln still vacant. These properties seem to be destined for redevelopment as Transit-Oriented Developments (TOD) as this type of high-density/low parking spaces development is starting to take hold.

The Peace School, yoga and meditation studio at 3121 Lincoln has a big "Building for Sale" sign in the window. Another sign says The Peace School is still open. They have been in this space since 1988.

Boston Market in the Ashland/Wellington Dunkin Plaza has a brand new big yellow notice dated 6/28/2025 – "Notice: Off limits. Do not Enter. City of Chicago, Dept of Buildings, Bureau-Demolition. I don't know if that means the building is going be demolished. I read somewhere that a **Panera Bread** might go in? There is a Panera at Fullerton and Damen.

Congratulations **Beermiscouous** on their 10-year anniversary.

IN CLOSING:

Any one-level vacant building on Lincoln Ave. is destined to be demolished and built as a TOD Development. After all previous area developments were built as Condominiums, the tide seems to turn to Residential Apartment Buildings like Wrightwood Furniture and the recently voted on a 5-story, 40-unit Rental Development on 1200 W. Belmont. There will be ground-level retail in these projects. That space will be new, so maybe it will be easier to rent. But it appears there will continue to be years and years of vacant store fronts. The smooth sidewalks are nice.

OTHER INFORMATION

South Lakeview Blue Park Playlot – Fundraising for planned Renovation/Repairs - \$100,000 still needed

The South Lakeview Park Advisory Council is working with the Chicago Park District on the renovation/repairs at the Playlot. The total project will cost \$450,000. After funding commitments from Alderman Waguespack, State Senator Sara Feigenholtz and South Lakeview Neighbors, the plan is about \$100,000 short. The Council held its first fundraiser on August 10.

Wellington Neighborhood Greenway – traffic, bicycling project from Leavitt to the Lakefront

CDOT expects to begin construction of the proposed following Project in late Summer or early Fall. CDOT's purpose is to:

- Promote safer vehicle speeds
- Provide a biking alternative to riding on Diversey or Belmont
- A better organized street that is more predictable for everyone

- Improved access to trails, schools, CTA stations and more
- Remove the left turn lane on Wellington going eastbound (on the west side of the intersection)

Highlights of the Plan:

- The Greenway will be on Wellington Ave. from Leavitt to Inner North Lake Shore Drive.

 -Advisory Bike Lanes from Ravenswood to Ashland and from Southport to Sheffield (where Wellington is two way). 1) For Bikers Bike lanes will be marked by dashed white lines, 2) Drivers will drive slowly in the center of the street. When an oncoming car approaches, the driver will check for bikers in the Bike Lanes then drive partly in the Advisory Bike Lane. When oncoming traffic clears, Driver will move back into the center of the street.
- ContraFlow Bike Lanes on the One-Way sections heading west on Wellington:
 From Leavitt to Ravenswood, Ashland to Southport and Clark to the Lake Shore

For Bikers - a ContraFlow lane will be marked allowing Bikers to ride in the opposite direction of one-way traffic.

For Drivers – be aware of Bikers going in the opposite direction, do not drive in the ContraFlow lane, when parking, yield to Bikers before parking across ContraFlow lane, before opening car door, check Bikers going the opposite direction.




